EFIC Diploma in Pain Medicine



Requirements for examination and application protocol

Date of first examination: March 31st, April 1st 2017 - Madrid, Spain

Registrations:

Registrations can be done HERE!

Examination Requirements:

- 1. Medical Degree details and certification, proof of medical registration.
- 2. Curriculum Vitae detailing experience of pain management in current and previous posts.
- 3. Letter of support or endorsement from two referees. For example, a head of department, clinical director or senior colleague. One could also be an EPF (EFIC) Councillor or Chapter Executive Board member. This should state that the candidate is in good standing in their country, and in their department, and is involved in seeing and managing patients with pain on a regular basis.
- 4. Completion of application form online
- 5. Non-returnable fee of €600
- 6. Visa letter if required
- 7. Online file of 5 case histories of patients assessed and treated personally by candidate, including presenting symptoms, brief details of disability and distress, differential diagnosis, management and outcome. History usually not to exceed 500 words for each case history. Candidates will be examined on one of the case histories, and will be expected to show knowledge about the type of case submitted. Submission to be at least 2 weeks before examination.
- 8. All information to be in English, or translated to English.

The Examination:

The first examination will take place on Friday March 31st and Saturday April 1st, 2017, in Madrid, Spain. It is envisaged that candidates can fly in on the morning of 31st, stay over for one night and depart after 13.00 from the examination venue on 1st April.

The venue is University Hospital HM Monteprincipe (hmmonteprincipe.com), Av. De Monteprincipe, 25, 28660 Boadilla del Monte, approximately 20 km from Madrid International Airport. The recommended hotel is **Marriot A C La Finca** but alternative accommodation can be researched by the candidate.

Examination Coverage:

The MCQs will cover the curriculum. Knowledge requirements are broad but not deep. All MCQs will be based on the curriculum and the reading list; answers will be supported by the reading list. Fifty questions will consist of a stem, followed by 5 individual statements, to be marked by the candidate "True" or "False" (info re own computer). There will be 2 Vivas, oral examinations. Both will last for 10 minutes. One will be a discussion on one of the candidates' submitted case history. The other will cover general pain medicine. The Objective Structured Clinical Examination (OSCE's) There will be 6 stations, each representing a simple clinical situation. Each station will have a 5 minute period of questions, scored in an objective fashion.

A great experience at the Bergamo Pain School 2016

I am very grateful for having the opportunity to attend Bergamo Pain School and for that I would like to thank everyone in both European and national associations. Professor Casale and his team were excellent hosts. They made us feel very welcome and they led us through everyday activities quite smoothly. A lot of experience and knowledge which was integrated in interactive workshops have helped us enrich our knowledge, as it was rather clinically oriented. We enjoyed a beautiful town of Bergamo. The accommodation was very good and all the people were very kind.

We were provided with information incorporated in practical advice related to the diagnosis of neuropathic pain, from patient's history, to questionnaires, clinical examination and objective diagnostic tools, such as electroneurography somatosensory evoked potentials, QST, fMRI, skin biopsy, autonomic nervous system testing etc. Dr Hansson patiently guided us through theory of the QST, and afterwards we had an opportunity to test QST and to personally feel sensation from it. We broadly discussed about available therapy for neuropathic pain as well as targets for potential new drugs. Furthermore, we had a chronic pain patient where we could test our ideas about the causes of pain and discuss potential therapy.

Also, we had opportunity to exchange experience with participants from other countries. On the other hand, during lectures, we learned a lot of about differences in organisation, treatments or procedures in different countries. During our visit to Habilita Hospital in Bergamo, we had a lecture about the assessment of the patients with barriers to communicate and had chance to see the organization and available equipment. We had an opportunity to observe botulinum toxin ultrasound guided injection in a patient with spasticity after stroke.





One of the greatest impressions from this pain school was definitely a discussion section. We actually discussed about all topics, even during the lectures and every professor encouraged us to stop him during the lecture and ask if something was not clear. In this manner the majority of the lectures became a broad discussion where everyone had the opportunity to ask question, state their opinion and share their experiences. These circumstances relaxed the atmosphere and every student could ask even "trivial" questions. Every professor generously shared their

experience with us and we did not hesitate to ask. For such a healthy atmosphere, we can be thankful especially to Dr Casale, Dr Hansson, Dr Bouhassira, Dr Garcia-Larrea and Dr Hanna.

We have seen many potential solutions for organization problems back home. Finally, we have seen through the complexity of the chronic neuropathic pain therapy and more importantly, we have recognized our place as physical medicine and rehabilitation specialists in multidisciplinary team which should struggle with this overwhelming problem. This recognition will provide us with the determination and motivation for continuous studying and practicing, as well as scientific work in this field in the future. Once again thank you very much for this great opportunity.

European Civic Prize on Chronic Pain - Collecting Good Practices



Active Citizenship Network is launching the project "EU Civic Prize on Chronic Pain - Collecting good practices". The aim is to give evidence of existing good practices in European countries in terms of struggle against pain.

Establishing a "European Civic Prize on Chronic Pain", based on the selection of the practices presented by different healthcare stakeholders (patients'associations, health professionals, private and public hospitals, universities, etc.) will provide an occasion for demonstrating what this community can offer in terms of good practice and experiences which are useful in raising awareness about the condition, enhancing the body of knowledge of positive cases and success, and strengthening commitment to this topic.

The public European celebration of the Prize (final event planned for June 2017) will represent the recognition of ongoing excellence. We like to think that this will be the first in a series of prizes – perhaps every two years – awarded to celebrate progress in the treatment and manage of chronic pain. We will invite most of the representatives of the collected good practices to this event. This will start the creation of a network of best practice practitioners, able to provide information, advice and practical help to each other. A Jury, composed of international experts in chronic pain (from universities, healthcare professionals and providers' organisations, civic and patients' associations etc.) will choose the winners. The winners will be given an expenses-paid visit to another winner and a publication in English in a suitable journal.

The Editorial Board of the European Journal of Pain (EJP) met for a strategic meeting in Lyon on 18-19 November this year. The meeting was hosted by the Editor-in-Chief (E-i-c) Luis Garcia-Larrea and virtually all Section Editors could attend the meeting, including the President-elect of EFIC Bart Morlion, the Managing Editor Bettina Haake-Weber as well as former E-i-C Hermann Handwerker and two representatives of the Publisher Wiley-Blackwell. The meeting was mostly conducted in brain storming mode and lively discussions lead through the agenda that included a number of points crucial for the future development of EJP:

- launching of a new Web interface for the Journal by Wiley,
- renewal of the Advisory Board,
- new strategies improving impact, citation index and visibility, including a simple procedure to get EJP full-text access for EFIC members,
- launching of a letter-from-the Editor to all subscribers, potential readers and authors,
- dissemination the EJP Table of Contents through mail and the EJP App

Significance:

This position paper provides expert recommendations for primary care physicians and other non-opioid specialist healthcare professionals in Europe, particularly those who do not have ready access to specialists in pain medicine, on the safe and appropriate use of opioid medications as part of a multi-faceted approach to pain management, in properly selected and supervised patients.

"Blockade of sigma 1 receptors alleviates sensory signs of diabetic neuropathy in rats"

Paniagua, N., Girón, R., Goicoechea, C., López-Miranda, V., Vela, J.M., Merlos, M. and Martín Fontelles, M.I.

Significance:

Blockade of $\sigma 1R$ avoids the development of diabetic neuropathy in rats, and may represent a potentially useful therapeutic approach to peripheral neuropathies in diabetic patients.

"Neuropathic pain prevalence following spinal cord injury: A systematic review and metaanalysis"

Burke, D., Fullen, B.M., Stokes, D. and Lennon, O.

Significance:

This systematic review and meta-analysis records pooled point prevalence of neuropathic pain post spinal cord injury at 53%. Additional pooled analysis shows that neuropathic pain is more common below the level of lesion, in patients with tetraplegia, older patients and at 1 year post injury.

"Restoring movement representation and alleviating phantom limb pain through short-term neurorehabilitation with a virtual reality system"

Osumi, M., Ichinose, A., Sumitani, M., Wake, N., Sano, Y., Yozu, A., Kumagaya, A., Kuniyoshi Y., and Morioka, S.

Significance:

There was no objective evidence that restoring movement representation by neurorehabilitation with virtual reality alleviated phantom limb pain. This study revealed quantitatively that restoring movement representation with virtual reality rehabilitation using a bimanual coordination task correlated with alleviation of phantom limb pain.





News from our Chapters





News from the Slovenian Pain Society (SZZB)

The Slovenian Pain Society (SZZB) is celebrating its 20th birthday. To mark the occasion, we will organize a small celebration next March. Meanwhile on 11th of November our 19th annual meeting took place in Ljubljana. This year's topic was on joint pain. We are currently updating the guidelines for prescribing opioids for chronic non-cancer pain. We used the opportunity to outline these guidelines that will be published next

year. The main session of the meeting was a discussion between general practitioners and various specialists. A GP opened the discussion by presenting interesting cases of patients with joint pain. The main points of discussion included the appropriate treatment options and when to refer the patient to a specialist. The meeting continued with orthopaedic surgeon, a physiatrist, a rheumatologist, a neurologist and an anaesthesiologist presenting various cases. Questions from the audience facilitated a debate. At the end of the program, a popular Slovenian singer and songwriter Vlado Kreslin performed some of his songs.









News from the Romanian Pain Society

The annual conference of the Romanian Association for the Study of Pain (ARSD) was held in Bucharest, Romania from 27-29th October. Over 200 participants from different specialties attended: Rehabilitation Medicine, Anesthesiology, Orthopedics, Obstetrics - Gynecology, Rheumatology, Neurology, Neuro – Surgery, Internal –Medicine, Family Medicine and General Surgery.

A pre-conference course was held on the Day 1 on the different aspects of musculoskeletal pain; from medical evaluation and therapeutic solutions to socio-economic and societal consequences of chronic pain.

The official opening of the Conference was held on Day 2 with Prof. Chris Wells, the President of EFIC (England) and Prof Roberto Casale (Italy) in attendance. Prof. Chris Wells succinctly presented general information on the EFIC organization as well as the consequences of SDL in general pathology. He reviewed the role of EFIC in an international context, focusing on the training of the young doctors through participation in the EFIC Pain Schools in Klagenfurt, Bergamo, Krakow, Liverpool and Maribor. Both a University Curriculum (appearance in 2014-2015) and a Postgraduate curriculum have been developed (Publishing 2016). In this context Prof Chris Wells announced that the first Diploma in Pain Medicine will take place in Madrid (March 31 to April 1, 2017). Prof. Roberto Casale (Neurology and Medical Recovery specialist) presented very interesting data relating to both experimental and clinically focused research in the correlations between chronic pain and functional somatic aspects, (joint pain, joint mobility, muscle strength and endurance and movement).

In Part 2 conference speakers from different specialties (Medical Rehabilitation, Anesthesiology, Psychiatry, Neurology, Neurosurgery, Occupational Medicine) presented on the topic of joint pain and the need to address the inter and multidisciplinary concerns relating to conservative and surgical issues. In Part three resident doctors were invited to present. This facilitated an effective dialogue between generations and between medical and surgical clinical specialties. New topics included pain in obstetrics and gynecology and postpartum recovery. The following day focused on the many aspects of somatic and visceral pain in traumatology and orthopedics, obstetrics and gynecology.

Over 16 speakers discussed the role of the interdisciplinary team including patient flow and the role of each member of the interdisciplinary team in patients with central and periarticular joint pain. The overall theme of the conference included the importance of appropriate training, improving information and communication and providing models of different medical practice specialties to target articular and periarticular pain.







News from the Professional Health Association, Kosovo

The 6th International Conference the Treatment of Pain was held on 28th and 29th October in Prizren, Kosovo. The meeting was organised by The Professional Health Association, in cooperation with the Ministry

of Health of Kosovo, the European Pain Federation, EFIC, the International Association for the Study of Pain (IASP), and the Patients' Rights Association in Kosovo (PRAK). Twenty-four international experts and 12 local experts in the field of pain spoke at the meeting. The conference was attended by 800 participants from various clinical areas including anesthesiologists, neurologists, surgeons, gynecologists, Otolaryngologist, dentist, neurosurgeon, physiotherapists, pharmacists, nurses and other health workers who have a special interest in the diagnosis and treatment of pain.



The conference addressed various topics for pain management while its main topics was "Treatment of pain in the joints". The PHA has joined the campaigns of IASP and EFIC; "Global Year Against Pain in the Joints." The event was accredited by the Ministry of Health (Board for continuing professional education) with 15 points credit for participants, and 20 points credit for lecturers.





News from the Association of Pain therapy in Bosnia and Herzegovina (APTBH)

2016 is the European Global Year against Joint Pain and this was marked through these activities in Bosnia and Herzegovina. The aim is to train doctors in Bosnia according to the EFIC pain medicine curriculum; improve physicians' and clinical specialists' knowledge and skills, to advance the understanding of pain mechanisms, prevention and the treatment of Join pain, the assessment of a range of joint pain syndromes as well as the cost of chronic pain. The education sessions included workshops for a range of practicing health care workers for more disciplines. Teaching and training in Interdisciplinary PM on Joint pain during of 3 all day courses with 5 sessions and hand workshops. Three all day workshops with 5 sessions took place from 6-9th September 2016 at 3 locations in Sarajevo. The sessions included 5 lectures lasting 45 minutes each, an interactive lecture and Workshop, case studies, interactive knowledge test, and discussions. Five clinical "Hand Workshop" lasting 90 minutes each also took place, with multidisciplinary participants including, anesthesiology, rheumatology, rehabilitation specialists, and neurologists. Between 20-25 doctors participated in each group.







News from the Ukrainian Association for the Study of Pain

The Second East-European Congress on Pain took place at the beginning of June 2016 in the sunny city of Odessa. This Congress was one of the biggest pain meetings in Eastern Europe. It featured 3 days of fruitful discussions, lectures, topical seminars and hands-on workshops. Best clinical practices, truly multidisciplinary scientific program and outstanding social activities made the Congress really successful.

The Congress was organized by the Ukrainian Association for the Study of Pain under the auspices of the European Pain Federation EFIC, and with support of the Moldavian and Latvian associations for the study of pain. Throughout the three days the latest pain research from around the world was discussed, covering a wide variety of topics from the fundamentals of pain to pearls of wisdom in the pharmacological and non-pharmacological management of pain. The Congress program featured 17 plenary and topical sessions, satellite symposia, hands-on workshops and video cases presentations. The Multidisciplinary program attracted basic scientists and clinicians from 21 medical specialties.



Almost 300 participants from 15 countries attended in the Congress; Austria, Belarus, Canada, Germany, Israel, India, Italy, Ireland, Latvia, Moldova, Portugal, Russia, Saudi Arabia, United Kingdom and Ukraine. In total 48 speakers from 12 countries shared their best experiences with the Congress participants. A special issue of the Ukrainian Journal of Pain was presented at the Congress. Aside from original papers, abstracts of the Congress were also published.

Throughout the Congress the presentations featured simultaneous translation, so a language barrier was not an issue. A warm atmosphere facilitated the establishment of new acquaintances and promoted productive discussions. All the presentations had a practical perspective that promoted lively discussion. The organizers would like to thank all the participants, speakers and partners for their contribution and invite everybody to take part in the Third East-European Congress on Pain in Kyiv in 2018.

Meetings: Past and Future

Past Meetings

Seasons Greetings from a sunny winter morning in London and I hope this finds you well. After the colors of the fall, the trees are devoid of leaves, the days are now getting shorter and the nights are getting colder and each day starts with the crisp chill of a winter morning in England, though we are still waiting for the first snowflake. There have been several meetings in October and November which I have been privileged to attend and I am sharing

some of my thoughts here. After the successful meeting in Dubrovnik, Croatia of the First EFIC Topical Symposium, it was a long flight to Yokohama, Japan to attend the 16th World Congress on Pain under the auspices of the International Association for the Study of Pain. This was also my first visit to Japan after a very long time and I did have the opportunity to see the sights of Mount Fuji-san, take ride on the Shinkansen "bullet train" and enjoy the sights of Tokyo and Kyoto.

The meeting was attended by more than 4400 delegates from across the globe. Dr Roger Fillingim from the University of Florida gave a wonderful talk on the individual differences in pain and about understanding what makes pain a very personal experience. It was interesting to hear the varying perspectives from various corners of the world at the Special Session on Opioids from renowned experts including Drs Jane Ballantyne, Sushma Bhatnagar, Penny Briscoe, Doug Gourlay and Thomas Tolle. It was an enlightening talk by Dr John Cryan from Cork describing the role of gut microbiota as a key regulator in visceral pain. The two plenaries on the afternoon of Wednesday 28 September was also very interesting. Prof Herta Flor delivered the John D Loeser Distinguished Lecture – "Pain has an element of Blank: A Biobehavioural approach to chronicity". This was followed by a plenary lecture by Dr Patricia Lavand'homme on the transition from Acute to Chronic pain after surgery. This was further discussed at the topical workshop hosted by the Acute Pain SIG by Drs Dominique Fletcher, Joel Katz and Esther Pogatzki-Zahn on Acute and Chronic Pain after Surgery: Risk Factors and Preventive Strategies.

Prof Frank Porreca delivered the Ronald Melzack Distinguished Lecture on Reward and Motivation in Pain and Pain Relief. Prof Stephen McMahon delivered the John J Bonica Distinguished Lecture titled "Why Me? Neurobiological Mechanisms of Pain Vulnerability". I was also interested to listen again to Prof Mike Bennett talking on mechanism-based cancer pain therapy and Prof Lorimer Moseley talking about Innovative Treatments for Back pain. There were several lectures and workshops that covered a wide range of subjects including paediatric pain, post-amputation pain, mechanism of neuropathic pain and immune system and pain amongst other subjects. It was a very enjoyable congress and I would like to take this opportunity to thank Prof Rolfe Detleef-Treede, Immediate Past-President of IASP, Prof Claudia Sommer, Chair of the Scientific Committee and Prof Noguchi, Chair of the local organizing committee for putting together a wonderful meeting.



The second International Congress of Moldovan Society for the Study and Management of Pain in partnership with EFIC, Ukrainian and Romanian Associations and the Moldovan Society of Anaesthesiology was held in 20-22 October at the Palace of National Trade Union Confederation of Moldova in its capital Chisinau. The meeting was attended by more than two hundred delegates The President of the Moldovan Pain Society, Prof Adrian Belii and Dr Iana Burmistr have worked hard to make this meeting a success and it was great to see eminent colleagues like Prof Silviu Brill (Israel), Prof Adriana Sarah Nica (Romania), Prof Igor Romanenko and Dr Vladimir Romanenko working together to make this meeting a great success.
